



## United Way Awarded \$100,000 Impact 100 Greater Wausau Grant for New Mobile Closet

Clothes on wheels— United Way of Marathon County was awarded a \$100,000 Impact 100 Greater Wausau grant Monday May 15, and is now one step closer to bringing a **Mobile Closet to the community**.

This initiative expands our existing Community Closets and eliminates barriers by bringing free clothing to accessible locations throughout the county. The Mobile Closet will serve the target population where they already spend time: rural schools, human service agencies, workplaces and neighborhoods with high ALICE (Asset Limited, Income Constrained, Employed) populations.

In Marathon County 29% of households fall under the ALICE threshold, and in the city of Wausau that percentage

increases to 42%.

ALICE households are hard-working people, but one crisis away from financial disaster.

In addition to the soon-to-be Mobile Closet, our **on-site Community Closet will reopen** to the community July 9!

Guests of all ages will be able to enjoy in-person shopping. Rebecca's Closet and the Career Closet are being merged into one, offering every day, casual clothing for individuals and families.

In preparation for the re-opening, we are currently working to fill the racks inside the Community Closet. Some of the greatest needs are boy's and girl's bottoms in size 6 as well as men's casual clothing and shoes. It's because of our supporters that we are able to provide an opportunity like this for the community.

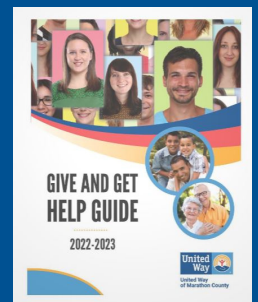

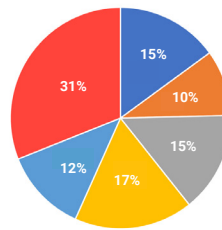
